- The Council Development Committee is recommending not purchasing or demolishing Story County Medical Center's wind turbine; rather allow them to sell it. More will come on this issue.
- The website now has a Project page added. The City Hall Campus Project and the 2015 Asphalt project will be located there. The page will be updated with locations, map, timelines and in the future will show bidding and project status. The public can frequent the page to get project status updates.
- Wednesday staff will be attending an all day Customer Service and Dealing with Difficult People Training sponsored by the Chamber at Gates Hall.

Mayor Lynn Lathrop reported the Public Safety Department did a super job on the recent fire. Ray Reynolds responded that Chris Brandes and Brad Melton were first on the scene. Jeff Stensland will give a report shortly. A life was saved.

Shawn Cole advised he will be attending training a couple days this week.

Jeremy Huntsman thanked the council for the new agreement with HR Green.

Ray Reynolds reported the disaster drill held with DuPont, Story County Medical Center and the Fire Department was held last Saturday. Approximately 20 attended. They walked through problems. Ray turned the floor over to Jeff Stensland, Assistant Fire Chief to report on the fire. Jeff Stensland reported on a fire on the first floor of Courthouse View Apartments. The apartment was occupied at the time. They were able to get everyone out. The guys did an awesome job, a life was saved. Stensland stated the Public Safety Department function is working because of the leadership of Martinez and Reynolds. Reynolds advised there may be some commendations coming.

Ric Martinez reported Channel 13 was here doing a follow-up story on the fire. There was a fire in Fort Dodge as well but ours had a success story. He also advised with Johnson's promotion there is another officer opening. This will be filled next fall.

Kerin Wright advised staff will be interviewing and hopefully hiring next month for the open position in Administration.

Larry Stevens thanked the council for approving the contract. Lincoln Highway survey should begin in the next day or so. The City Hall Campus Project is ready to let. Liz Hansen advised the Betterment Committee will be meeting on March 3 to discuss their options. Financing is needed to proceed. The county money must be spent by November of 2015 or they will lose it.
