Elizabeth Hansen:

- The Planning and Zoning Intern Ruth Holstrom is working on a Main Street Application and assembling a steering committee together. Ruth is working on a letter on behalf of the Chamber, NEDC, and the City to jointly facilitate.
- Hansen advised council the annual SMART Conference, hosted by the lowa Economic Development Authority, is being held on April 28th. Let Hansen know if interested in attending.
- The RFP/Qualifications for the Rec Center Study was included in the packet. It will be sent out at the end of the week.
- Code Red analysis was also included in the packet. It is recommended at this time to keep the system. The procedure policy will be updated to include the additional uses.
- Rotary Board and IMPI meetings were rescheduled.

Mayor Lathrop attended the Step into Storytime for Story County program at the elementary school. Over 150 children attended. The year prior, there were 190.

Beth Williams noted this week is National Library Week. There will be Musical Lunches at Noon. They are collecting for the Community Cupboard the month of April. Quotes were sent out for the Landscaping with a return date of April 20th. These will be submitted to the council at the next meeting. The Friends of the Library will be holding their book sale April 29th and 30th. They will also be holding their annual membership campaign.

Mike Neal advised staff has been filling pot holes, sweeping streets and fixing water main breaks. They will be putting down gravel on the outskirts of town soon. Sometime in June placing dust control on the gravel.

Ray Reynolds reported the Fire Association donated a new infra red camera. He showed council the difference between the new and the old one. The new camera is lighter and has several additional features. Reynolds is hoping to write a FEMA Grant for three more cameras.

Shawn Cole noted spring projects are beginning. The school and Story County Medical have both began their projects.

Kerin Wright relayed staff received training on the new online payment system. Utility payments are now being made through lowa Interactive. We will be adding other payments options in the future. Next week Wright will be attending the lowa Employment Conference in Altoona.
