# NEVADA CITY COUNCIL - MONDAY, MARCH 13, 2017 6:05 P.M.

## 1. CALL TO ORDER

The City Council of the City of Nevada, Iowa, met for a meeting in the Council Chambers located at City Hall, 1209 6<sup>th</sup> Street, Nevada, Iowa. Mayor Lynn Lathrop, convened the meeting at 6:05 p.m. on Monday, March 13, 2017, pursuant to the rules of the Council. The agenda was posted on the official bulletin board in compliance with the open meeting law.

9. REPORTS (City Administrator/Mayor/Council/Department Heads)

Matt Mardesen:

- March 8<sup>th</sup> the Iowa Economic Development Authority Annexation Board approved the City of Ames annexation request by a 4/1 vote.
- Leadership Nevada is in the planning stages for next fall.
- Tuesday, February 28<sup>th</sup> Mardesen met with the Golden K Group
- Mardesen will be in court on March 14<sup>th</sup> and 15<sup>th</sup> for a pending ICAP Claim
- The Pre-construction meeting for the 2017 Street CIP Project was held on March 8<sup>th</sup>. The contractors plan to begin work on March 29<sup>th</sup>. Letters will go out to the property owners.
- Mardesen gave a brief update on the Wellness/Recreation center

Mike Neal reported on the snow event. This will again cause potholes to deteriorate.

Ray Reynolds advised with the nice weather he and Kali Warner have begun working on nuisance abatements. Approximately 54 notices went out and they are getting positive reactions.

Ric Martinez noted they will be posting some of the nuisance pictures on their Facebook page to show residents some of the issues they look at when citing a nuisance. The department is waiting on post test before they make a job offer. Hopefully by the end of the month they will be ready.

Kerin Wright relayed her satisfaction with the report from Dorsey and Whitney regarding the City's Municipal Continuing Disclosure Cooperation (MCDC) Initiative. The SEC has confirmed it does not intend to take enforcement action against the City. She also attended the annual training from Dorsey and Whitney for the Continuing Disclosure required on most of the City's bonds.
