1. CALL TO ORDER

The City Council of the City of Nevada, Iowa, met for a meeting in the Council Chambers located at City Hall, 1209 6th Street, Nevada, Iowa. Mayor Lynn Lathrop, convened the meeting at 6:00 p.m. on Monday, April 24, 2017, pursuant to the rules of the Council. The agenda was posted on the official bulletin board in compliance with the open meeting law.

8. NEW BUSINESS

A. Approve Purchase of Thermal Imaging Camera for the Fire Department

Motion by Brian Hanson, seconded by Brett Barker, to <u>approve the Purchase of a FLIR K55 and K2 Thermal Imaging Camera from Alex Fire Apparatus for \$5,650.00</u>. After due consideration and discussion the roll was called. Aye: Hanson, Barker, Kelly, Mittman, Walker. Nay: None. The Mayor declared the motion carried.

9. REPORTS

Matt Mardesen:

- Maggie Davis' Multiage Class requested to paint storm drains in an effort to combat the global problem of garbage. Ric Martinez responded to the class and Mike Neal and Martinez will work with them to ensure the safety of the students.
- The Rec Center Task Force will meet May 4th at 10:00 a.m.
- Staff met with Copper Tree on April 17th to discuss an EAB Replanting Program. The goal is to have a program to present to council by June or July.
- Mardesen attended the Iowa Government Finance Initiative Workshop with Kerin Wright on April 20th. The City's fiscal condition was evaluated along with comparables to other cities.
- April 20th the Public Safety Department held a mock crash event at the Nevada High School. Mardesen praised the department for the event and the cooperation among the other entities that participated.

Brett Barker reported the 4th Annual Story County Freedom Flight event raised approximately \$5,600. Proceeds will fund the Middle East Conflict Memorial Mall bus trip for veterans.

Ray Reynolds advised on Thursday he will participate in a conference call with Underwriters Laboratory to discuss protocol for stover fires. DuPont is Co-sponsoring the initiative. Reynolds has been asked to serve on the Fire Code Action, SMART Buildings Code and the Pallet Storage Code Committees. These committees will look at the definitions for corn stover and how it should be noted in the code.

Shawn Cole reported the projects are ahead of schedule. Planning and Zoning will meet next Monday to discuss allowing salvage services in the Railroad Corridor.

Tim Hansen relayed the Cemetery has received a \$25,000 memorial from Mary Harms to be used for green beauty of the grounds. An ICAP Grant for \$1,000 was also received for purchase of tubes and life jackets at the aquatic center. A storage facility will be built at Billy Sunday Field funded by the high school. Staff is preparing the cemetery for Memorial Day. Last Thursday high school kids were at the aquatic center and SCORE participating in Service Day. Marlys Barker inquired about the security/safety issues with individuals fishing

at the pond next to the aquatic center. Hansen replied the city does not stock the pond and it is posted for no swimming. Ric Martinez will assess if there are any parking issues that might need to be addressed.

Mike Neal reported the water department initially thought there was a water main break near Rolling Green. It turned out to be their service line.

Ric Martinez advised a conditional offer was made to a candidate with all tests completed. The employment offer will be made this week. This candidate is already certified. There is another non-certified candidate a conditional offer will be made to in the next day or so.

Kerin Wright relayed she attended the Iowa Municipal Finance Officer Associations Conference in Des Moines last week. An update was given on the revised elections process. More details will be known after the Story County Clerk's meeting next month. Staff is assessing the need for another budget amendment.

Larry Stevens noted last Monday documents for the Orchard View Subdivision were submitted to the Story County Planning and Zoning. They will meet on May 3rd and refer it on to the Story County Supervisors on May 16th. The 2017 Asphalt project was awarded tonight, Manatts has advised it will be late summer/early fall before the project begins. Stevens advised they are finishing the sidewalk project and it should be ready for bids next month.

There being no further business to come before the meeting, motion by Brett Barker, seconded by Brian Hanson, to <u>adjourn the meeting</u>. Following voice vote, the Mayor declared the motion carried at 6:45 p.m. the meeting adjourned.
