- b. Mardesen continues to meet with Dr. Gray, school staff and engineers regarding the high school baseball field project. Final plans for the project will be released soon.
- c. Discussion has begun with the city engineers on the downtown street project. There are plans to hold an initial meeting this summer with business owners.
- d. Mardesen attended a public hearing regarding potential options to correct the drainage ditch in district #5 where the city owns some land.
- e. Mardesen attended a meeting to update the Story County Hazard Mitigation Plan. He is updating the City's information in preparation for the next meeting.
- f. Luke Spence asked if the email system was ready to be switched over. Matt explained that it was ready and would be switched over in next few weeks.

Mayor Barker reported that the Lincoln Highway Days board would like to discuss their agreement for city services. He went to the Ames Morning Rotary meeting and listened to a program about how they send funding to the police department to help children of the community. Mayor Baker stated that the Substance Abuse Community Conversation on March 22nd at Gates Hall went well.

Council Member Hanson reported on the Coffee with Council that he and Council Member Sampson attended. He is disappointed in the lack of public attendance. It was suggested to pick a topic for each Saturday.

Planning and Zoning Supervisor Cole reported P&Z will be having a public hearing on April 2nd to the rezoning of South Glen Subdivision. He also handed out a map showing the RAGBRAI route and event area that he will be submitting to the group at the next RAGBRAI meeting.

Public Works Director Mike Neal reported that the city received the order of salt that has been delayed. Street crews are working on potholes and replacing signs when the weather cooperates.

Fire Chief Ray Reynolds held up a copy of the CityScape magazine. Mardesen and Director of Fire/Ems Reynolds wrote an article on Ultra High Pressure Firefighting. A Letter of Appreciation will be going out to Shannon Groat for her help with the Sheriff's office. The stover fire code that Nevada has been working on for the stover piles in the area will be adopted to the International Fire Code. Fire Chief Reynolds reported that police officers are eating meals at the schools. There was an arrest made this past weekend regarding a letter sent to the school.

City Engineer Stevens advised that now with the ROW acquisition and warranty deed, they can proceed with Lincoln Highway and W. 18th Street and have letting on May 15th. He stated that the Central Business District improvements will have a lasting effect on the community.

City Attorney Erin Clanton was asked about the union contract. She continues to contact the union representative and has not received the signed document yet.
