# NEVADA CITY COUNCIL - MONDAY, MAY 14, 2018 6:03 P.M.

#### 1. CALL TO ORDER

The City Council of the City of Nevada, Iowa, met for a meeting in the Council Chambers located at City Hall, 1209 6<sup>th</sup> Street, Nevada, Iowa. Mayor Pro-tem Barb Mittman, convened the meeting at 6:03 p.m. on Monday, May 14, 2018, pursuant to the rules of the Council. The agenda was posted on the official bulletin board in compliance with the open meeting law.

## 2. ROLL CALL

#### 6. OLD BUSINESS

A. Ordinance No. 1000 (2017/2018): An Ordinance Amending the City Code of Nevada, lowa, by Amending (2) Chapter 41.13 (Fireworks), third and final reading

B. Request for Extension from Story County Medical Center regarding Wind Turbine located at the Wastewater Plant

Motion by Brian Hanson, seconded by Luke Spence, to <u>approve the request from Story County Medical Center for an extension on the removal of the Wind Turbine at the Wastewater Plant.</u> Motion by Brian Hanson, seconded by Luke Spence to <u>amend the motion to include the removal of the concrete base to a minimum of 10 feet</u>. After due consideration and discussion the roll was called. Aye: Hanson, Spence, Mittman, Nealson, Sampson. Nay: None. The Mayor Pro-tem declared the motion carried.

#### 7. NEW BUSINESS

A. Request from Virginia & Chadrick Johnson, 1420 4<sup>th</sup> St, for the city to vacate the alley behind three of their properties

After due consideration and discussion consensus of the Council was to refer the request to Planning and Zoning Commission.

B. Approve Purchase of Sun Shade for City Hall Campus Shelter

Motion by Dane Nealson, seconded by Barb Mittman, to <u>approve the Purchase of the Sunesta Sentry Screen from Rain or Shine of Iowa in the amount of \$8,700.00 for the City Hall Campus Shelter</u>. After due consideration and discussion the roll was called. Aye: Nealson, Mittman, Sampson, Spence, Hanson. Nay: None. The Mayor Pro-tem declared the motion carried.

# 8. REPORTS:

City Administrator Mardesen reported:

- The City's ICAP renewal will see a \$15,000 credit, but the bad news is we anticipate an increase in the work comp renewal through IMWCA.
- Attended the Story County Hazard Mitigation draft meeting. May 25<sup>th</sup> will be the final meeting.

- With the recent partnership between NEDC and AEDC, Mardesen and Patrick Sheets have been designated to be on the AEDC board. They attended their first meeting on April 27<sup>th</sup>.
- The Safety Committee Meeting was held on May 2<sup>nd</sup>. Staff reviewed incidents. It was also determined fire inspections will be performed on all city buildings.
- Attended the Alliant Energy presentation in Ames outlining the new energy incentives
  offered to businesses and residents. The Nevada community is scheduled for gas meter
  change outs in the near future.

Planning and Zoning Supervisor Cole updated the council on current projects and RAGBRAI.

Public Works Director Neal relayed that staff has been filling pot holes and trimming trees. Storm intakes are also being cleaned. Neal was informed of a few areas of concern.

Library Director Speer informed council the digitization has gone live. It is already being used. Speer is participating in a leadership/mentorship program and met her mentor last weekend. They are trying several new programs and challenges at the library.

City Clerk Wright briefed the council on the new bill that was passed for the Water Excise Tax.

City Engineer Stevens noted they have reviewed the traffic at 19<sup>th</sup> Street and S B Avenue and will have a memo shortly. Staff is working on the SCORE sewer line and Sidewalk projects. An outline of the bids for the Lincoln Highway/W 18<sup>th</sup> Street project will be finalized with the next couple days. Stevens advised stop signs at 19<sup>th</sup> Street and S B Avenue would require DOT approval.

Council member Nealson thanked staff for the quick response. He also noted that Council Members Mittman and Sampson, Dr. Steve Gray and Story County Supervisor Olson will attend the Community Coffee at Farm Grounds on Saturday May 19<sup>th</sup> at 9:00 a.m.

Council Members Spence and Mittman held their first full meeting with the Substance Abuse Committee.

Council Member Mittman reported she wrote a letter of support for a grant the Nevada Historical Society applied for.
