Motion by Greg Madsen, seconded by Fred Samuelson, to *approve the agenda* as posted. The roll being called the members voted as follows. Ayes: Madsen, Samuelson, Egeland, Haley, Johnson. Nays: None. Chair Johnson declared the motion carried.

Motion by Dianna Haley, seconded by Fred Samuelson, to *approve the minutes of the May 12, 2015* meeting as presented. The roll being called, the members voted as follows: Ayes: Haley, Samuelson, Egeland, Johnson, Madsen. Nays: None. Whereupon Chair Johnson declared the motion carried.

Request for variance by Cary & Sheri Martin to construct a Minor Subdivision of 5 sets of townhomes on the south side of Q Avenue between 5<sup>th</sup> & 6<sup>th</sup> with a 20 foot front yard setback and an 8 foot rear yard setback for those facing 5<sup>th</sup> & 6<sup>th</sup>, required front yard setbacks are 25 feet & rear yard setbacks are 20 feet.

After due consideration and discussion, Adam Egeland introduced and moved the adoption of Resolution No. 01 (2015/2016): A RESOLUTION APPROVING A VARIANCE TO THE ZONING CODE ALLOWING A REDUCTION IN THE REQUIRED TWENTY FIVE FEET SETBACK FOR FRONT AND TWENTY FEET REAR YARDS SETBACK TO A FRONT YARD SETBACK OF TWENTY FEET (20') AND A REAR YARD SETBACK OF EIGHT FEET (8') TO CARY AND SHERI MARTIN TO ALLOW FOR THE CONSTRUCTION OF FIVE SETS OF TOWNHOMES ON THE SOUTH SIDE OF Q AVENUE BETWEEN 5<sup>TH</sup> AND 6<sup>TH</sup> STREET, NEVADA, IOWA, which embodied the Board's decision.

There being no further business to come before the meeting it was moved by Greg Madsen seconded by Dianna Haley to adjourn the meeting. Following voice vote, Chair Johnson declared the motion carried and at 10:30 a.m. adjourned the meeting.
