There has been a bequest from Louis Koenecke in the amount of \$500.00. Beth will ask the family if they would like the library to purchase large print westerns or help pay for the landscaping project.

Motion by Board Member Barb Parker, seconded by Board Member Hank Zaletel, to approve payment of \$29,356.70 to Vic Scott Landscaping & Nursery for landscaping. Library Director Beth Williams reported on:
