Full payment is due within 60 days of reservation. A security deposit in the amount of Two Hundred Dollars (\$200.00) in the form of a separate check is also required at the time of reservation.

Any cancellations more than 60 days prior to the reservation date, will receive one half of the rental fee back and the entire damage deposit. If a cancellation is made less than 60 days in advance, no refund of the rental fee will be issued. The security deposit will be returned.

I agree to be personally and individually responsible for abiding by and enforcing the rules, along with the group or organization that I represent. I am authorized to sign this agreement on behalf of the organization.
