### ORDINANCE NO. 1048 (2023/2024)

# AN ORDINANCE AMENDING CHAPTER 65 (STOP OR YIELD REQUIRED) OF THE CITY CODE TO REQUIRE STOPS IN ADDITIONAL INTERSECTIONS

BE IT ENACTED by the City Council of the City of Nevada, Iowa, as follows:

**SECTION 1. SECTION MODIFIED.** Chapter 65 (Stop or Yield Required), Section 65.01 (Stops Required by Vehicles Entering Stop Intersection), Sub-section 29 is amended by inserting the following new underlined language and deleting the strikethrough language:

65.01 Stops Required by Vehicles Entering Stop Intersection.

# 65.01(29) On Nineteenth (19th) Street frontage road

- A. At intersection of Nineteenth (19th) Street
- B. North bound at intersection of H Avenue
- C. North bound at intersection of South G Avenue
- D. South bound at intersection of South G Avenue

**SECTION 2. REPEALER**. All ordinances or parts or ordinances in conflict with the provisions of this ordinance are hereby repealed.

**SECTION 3. SEVERABILITY CLAUSE**. If any section, provision or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional.

**SECTION 4. WHEN EFFECTIVE**. This ordinance shall be in effect from and after its final passage, approval and publication as provided by law.
