SECTION 1. SECTION MODIFIED. Chapter 65 (Stop or Yield Required), Section 65.01 (Stops Required by Vehicles Entering Stop Intersection), Sub-section 10 is amended by inserting the following new highlighted language and deleting the strikethrough language:

65.01 Stops Required by Vehicles Entering Stop Intersection.

65.01(10) On Sixth (6th) Street

- A. South bound at intersection of Highway 30
- B. At intersection of E Avenue 4-way
- C. At intersection of I Avenue 4-way
- D. At intersection of J Avenue 4-way
- E. At intersection of K Avenue 4-way

F. At intersection of Lincoln Highway (L Avenue) – 4-way
