LIBRARY BOARD OF TRUSTEES MONDAY, NOVEMBER 18, 2024, 5:00 P.M.

Chairperson Allison Severson presided and convened the regular meeting of Nevada Library Board of Trustees on Monday, November 18, 2024 at 5:01 p.m. at the Nevada Public Library, 631 K Avenue, Nevada, Iowa. The agenda was posted on the official bulletin board in compliance with the open-meeting law.

The roll was called indicating that the following named Trustees were present and absent. Present: Emma Cassabaum, Emily Fulton, Priscilla Gammon, Theresa Presley, Allison Severson and James Woodard (via Zoom). Absent: Tim McLaughlin.

Others in attendance were Library Director Erin Coughlin, and Donna Mosinski.

Motion by Board Member Emily Fulton, seconded by Board Member Thersa Presley, to <u>approve</u> <u>the agenda</u> as posted. The roll being called, the following named members voted. Ayes: Fulton, Presley, Severson, Woodard, Cassabaum, and Gammon. Nays: None. Chairperson Allison Severson declared the motion carried.

There was no one present who wished to address the Board at this time.

For Continuing Education, Erin Clanton, Attorney for the City of Nevada, spoke about legal considerations at the library. She reviewed age restrictions, confidentiality, and obscenity. Discussion lasted for 26 minutes.

Motion by Board Member Emma Cassabaum, seconded by Board Member Theresa Presley, to approve the Confidentiality Policy. The roll being called, the following named members voted. There was discussion regarding a water bottle filler replacing the drinking fountain. Erin was asked to continue taking bids.

Motion by Board Member Theresa Presley, seconded by Board Member Emma Cassabaum, to make Hoopla circulation limited to 4 circulations per person per month, remove the per item cap, and remove Hoopla access from limited accounts. The roll being called, the following named

The January Library Board Meeting will be on January 13, 2025 in the City Council Chambers so that the board can attend the City Council meeting for the annual library report.

Motion by Board Member Emma Cassabaum, seconded by Board Member Priscilla Gammon, to accept the resignation of Library Director Erin Coughlin effective December 28, 2024. The roll being called, the following named members voted. Ayes: Cassabaum, Gammon, Presley, Severson, Woodard, Fulton. Nays: None. Chairperson Allison Severson declared the motion carried.

The board discussed appointing an interim director and decided to put that on the December agenda.

Motion by Board Member Emily Fulton, seconded by Board Member Emma Cassabaum, to proceed with advertising for a new Library Director with the changes made to the job description. The roll being called, the following named members voted. Ayes: Fulton, Cassabaum, Gammon, Presley, Severson, and Woodard. Nays: None. Chairperson Allison Severson declared the motion carried.

Motion by Board Member Emma Cassabaum, seconded by Board Member Priscilla Gammon, to approve the FY2026 Library Budget. The roll being called, the following named members voted. Ayes: Cassabaum, Gammon, Presley, Severson, Woodard, and Fulton. Nays: None. Chairperson Allison Severson declared the motion carried.

Library Director Erin Coughlin reported on:

- The skylights have been ordered.
- A lot was accomplished on the staff development day on November 10th.
