The Application for an Excavation Permit includes the following:

- Application Form (This form must be filled out completely for all applications);
2. **What must be submitted?**
 - One (1) completed and signed Application Form.
 - An approved traffic control plan in accordance with the current Manual on Uniform Traffic Control Devices.
 - Description of work to be done, including any drawings or specifications deemed necessary by the City, start and completion date.
 - Erosion Control Plan
 - A check or cash for the application filing fee as established by the City Council.

No application will be accepted unless it complies with all the submittal requirements. Applications that are incomplete will be returned to the applicant without further review.
